## AMRUT

Rajpur Sonarpur Municipality is presently determined to supply drinking water to each household from available surface water resources through the Project AMRUT, the most awaited and prestigious project. On date, Honourable Chairman and Honourable CIC-AMRUT visited the site for intake jetty at Bhut Ghat near BNR and the route of raw water transmission main up to the Water Treat Plant of 124 mld capacity which is at the verge of completion and exclusive for this Municipality at Ward No 31 of this Municipality, Peyarabagan.

The capacity of intake jetty is 185 MLD and construction work is almost 60% done as on date. Out of the capacity, KMC will be allotted 45 MLD, Baruipur Municipality 16 MLD. So for our Municipality it is 124 MLD.

Laying of 1600 mm dia DI pipe, raw water transmission main also started from Bhut Ghat. After crossing Dumayine Avenue and Karl Marks Sarani it reaches Boat Canal, then the route is along the Boat Canal and near Chetla, it meets Tolly Naalah. After that it will be laid to Garia Mahasashan and then up to Water Treatment Plant within our Municipality. Over both the canal it is elevated. Over Dumayine Avenue, a stretch will be done by jack pushing, trenchless. Total length of raw water transmission main is 17.5 km out of which length of 1600 mm dia is 16 km, after Garia Mahasashan the diameter is 1400 mm of length 600 m. After that, 1200 mm dia pipe will enter the water treatment plant, the length is 900 m.

KMDA is taking care of the project.





### Water Treatment Plant (WTP) –

A joint inspection of the WTP site and the details discussion of water Supply project under AMRUT Phase-I & Phase-II was held at Jaihind conference hall . Dr. Pallab Kumar das, Chairman, Rajpur-Sonarpur Municipality, Janab Nazrul Ali Mondal, CIC, RSM and other officials of AMRUT, RSM was preset and from KMDA side DG of Waster Supply sector, Chief Engineer of this project along with Superintending Engineer , Executive Engineers, and assistant Engineers was present.







## **GIS BASED 5 YEARS PLAN**

GIS based Master Plan is being prepared under AMRUT sub-component. It has been decided by the State Government that the Municipality has to prepare a 5 years Draft Development Plan under this sub-component, and this Draft Development plan will be prepared through GIS based. A sensitization workshop was conducted at the Head Office of the Municipality to prepare this Draft Development Plan. The entire workshop was conducted at the facility by the Sri Saibal Guhothakurta, Chief Town Planner, Ud & Ma Department, Chairman of the Municipality , All CIC Members and all Elected Representatives were present.







Subsequent plenary discussions on DDP based on each local office were organized. Those meetings were facilitate by Dr.Pallab Kumar Das,Chairman, Janab Nazrul Ali Mondal, CIC - AMRUT, PWD, Water Supply and attended by the councilors of the respective wards, along with their EBS and officials from local offices and head office.





Meetings were also held with all the Govt and Private schools in the municipality for DDP preparation.





## WATER BODY REJUVENATION UNDER AMRUT 2.0

In AMRUT 2.0, our municipality will be permitted to do the 2<sup>no</sup> of Water Body Rejuvenation work in the first phase. Jadavpur University is working to prepare this DPR .

In the first phase, they collected water from water bodies and conducted water testing at their own laboratory as per the parameters of AMRUT.



In the second phase, they conducted a total survey with the helps of boats and drones on water bodies .



Expected by June 2022 preparation of DPR will be completed .

## Fecal Sludge Treatment Plant (FSTP)

FSTP is another important work of AMRUT 2.0 . All those who are identified AMRUT City it is compulsory for these cities in AMRUT 2.0 project must be prepared FSTP for their city. And this DPR also being prepared by Jadavpur University. Work is underway to lay out the site for this purpose. At the same time, work is underway to plan what could be used for possible purpose of recycling waste water. We hope that the work of prepare of this DPR can be completed very soon.



## SACHHA BHARAT MISSION

City Sanitation Action Plan under SBM 2.0 has been prepared and submitted to SUDA for approval . Ward Wise requirements for new individual toilets, Community Toilets and Public Toilets sent for approval, and at the same time the work of ODF + is going on. Representatives from Hijli Inspiration's office came and gave us handling support on how we can make ODF + work.



The community toilets and public toilets that we have so far are being evaluated on ODF+ rule as well.



## Marriage Ceremony in Shelter for Urban Homeless (SUH)

Sanhita is an Inmate of SUH Nibedita Bhavan. She has no family. After her parents' death she became mentally ill and admitted to Pavlov Hospital. After treatment she recovered but no place to live so she was sent to SUH by an NGO named ANJALI. She lived here for two years. On 3/5/22 she got married with Madhusudan Bhattacharya who worked as lab assistant. Marriage organized in Kalighat temple and reception held on 5/5/22 in Nibedita Bhavan. Honorable CIC, NULM, Mrs. Sonali Roy, I.C, Sonarpur P.S and I.C, Baruiapur Women P.S attended reception ceremony with other municipality officials and guests. All rituals including gaye halud, Aiburobhat celebrated in Nibedita Bhavan. It is the first time any NULM Shelter inmates got married in this way. It is a great achievement for Rajpur Sonarpur Municipality under the guidance of Honorable Chairman Dr. Pallab Kumar Das.







## Housing for All

Pradhan Mantri Awas Yojana (PMAY) aims at Providing Housing for All (HFA) by 2022 when the Nation Complete 75 years of its independence.

The Mission seeks to address the housing requirement of urban poor including slum dwellers through (i)“In Situ” Slum Redevelopment, (ii) Affordable Housing through credit linked subsidy, (iii) affordable Housing in partnership and (iv) subsidy for beneficiary led individual house. Under the mission, beneficiaries can take advantage under one component only.

We have projected almost 13000 beneficiaries among 178 slums in 6 years. Many slums have been selected for the year of 2015-16, 2017-18, 2019-20 & 2020-21 with Total beneficiaries of 2600. Cost of each dwelling unit is Rs. 3.68 Lakhs as per relevant department & P.W.D. schedule of rates.

Dwelling units consist of 2 rooms, kitchen & bathroom with the area of 339 Sq feet.

Dwelling Units of 2015-16 almost come to an end, we have also submitted the DRP of 2019-20, & 2020-2021 and the amount have already sanctioned. The project is expected to initiate within a short time

Pradhan Mantri Awas Yojana (PMAY) aims at Providing Housing for All (HFA) by 2022 when the Nation Complete 75 years of its independence.

The urban homeless persons contribute to the economy of the cities and thus the Nation as cheap labour in the informal sector; yet they live with no shelter or social security .The urban homeless service with many challenges like no access to elementary Public Services such as health, education, food, water and sanitation.Pradhan Mantri Awas Yojana (PMAY) also aims at providing a pucca house to every family with water connection, toilet facilities, 24 X 7 electricity supply and access.

Raipur Sonarpur Municipality is one of the fastest growing urban local bodies of Kolkata Metropolitan Area along with its population 4, 23724.

In 2015 the dream project “Housing for all “have been launched in our Municipality, after the intensive survey work the database for urban poor have been prepared. In the 1<sup>st</sup> (2015-2016) phase

the total beneficiaries of this project are 1012. All the documentation part have been completed and presently the municipality is in the constructional phase.

Presently we are working simultaneously in two financial year 2015-16 & 2017-18 and 2019-20
